# **Announcement Regarding Dividends from Surplus**

# (2) Reason

Our fundamental policy for dividends is to strengthen business operations while distributing earnings to our shareholders in a manner that reflects earnings in each fiscal year and preserves the stability of dividend payments.

Based on the consolidated performance trends in the current fiscal year, we examined the consolidated dividend payout ratio, retained earnings, and other items involving the dividend. In accordance with this examination, Helios Techno plans to pay an annual dividend of 35.00 year per share by paying year-end dividend of 35.00 year per share.
